TRADEMARK ASSIGNMENT

WHEREAS, Lighthouse Plastics, LLC ("Assignor"), a limited liability company organized under the laws of the State of Washington and having its principal place of business at 8210 Stinson Avenue, Gig Harbor, Washington 98332, has adopted and applied to register the ECOBARREL trademark, which is the subject of a U.S. trademark application Ser. Assignor warrants and represents that to the best of its knowledge and belief it is the exclusive owner of the Mark and that no other party has the right to use the Mark in commerce. Assignor further warrants and represents that it has not entered into any assignments, contracts, or other understandings with third parties that would conflict with the rights herein granted.

Assignor agrees that it or its representatives will, upon request, do all other lawful acts necessary to enable Assignee to obtain, maintain, and enforce full benefits from the rights and interests herein assigned.

This assignment shall be effective as of the date executed below, shall be binding on the successors and assigns of Assignor, and shall inure to the benefit of the successors and assigns of Assignee.
