### Assignment of Trademark Rights and Goodwill

NOW, THEREFORE, in consideration of the foregoing recitals, which are incorporated herein by this reference, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree as follows:

1. Assignment. Assignor hereby irrevocably and without reservation:

1.1 assigns, sells, transfers and conveys to Assignee all right, title and interest of any nature whatsoever in and to the Trademark Portfolio, any and all goodwill of the business associated with such Trademark Portfolio; and

1.2 transfers, conveys and assigns unto Assignee the entire right, title and interest in and to any and all causes of action and rights of recovery for past, present and future infringement of the Trademark Portfolio herein assigned.

2. Governing Law. This Trademark Assignment shall be governed by the laws of the United States and the State of California, without reference to conflict of laws principles. If any provision of this Trademark Assignment is held by a court of competent jurisdiction to be unenforceable, then such provision shall be eliminated, limited or modified to the extent required by applicable law and this Trademark

Assignment, as so modified or limited, shall remain enforceable in accordance with its terms. For the avoidance of doubt, no such modification or limitation shall be deemed to modify any other provision of this Trademark Assignment or render this Trademark Assignment invalid or unenforceable in its entirety.

3. Conflict with Assignment Agreement. This Trademark Assignment is made pursuant to and is subject to the Assignment Agreement. Nothing contained in this Trademark Assignment shall be deemed to supersede or modify any of the obligations, agreements, covenants or warranties of Assignor or Assignee contained in the Assignment Agreement. In the event that any provision of this Trademark Assignment be constructed to conflict with a provision in the Assignment Agreement, the provision in the Assignment Agreement shall be deemed to be controlling.



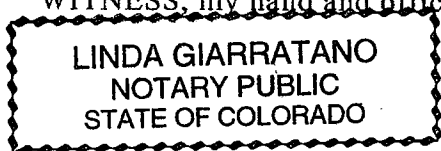


