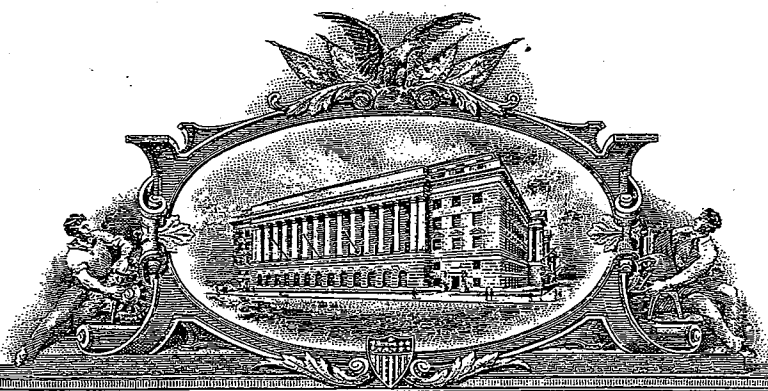
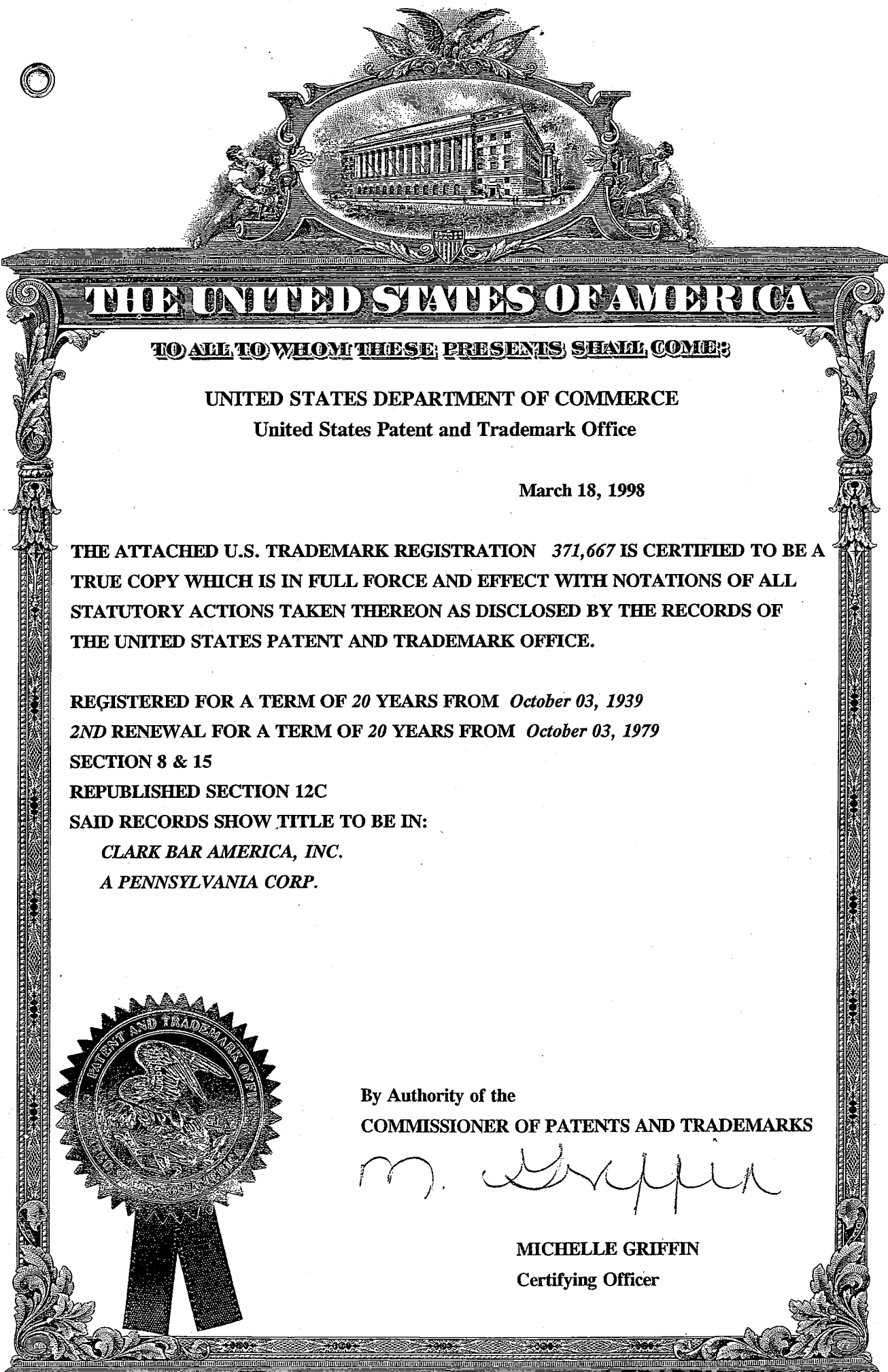

STATEMENT

To the Commissioner of Patents:

The Wayne Candies, Inc., a corporation duly organized under the laws of the State of Indiana and located at Fort Wayne, Indiana, and doing business at 113-121 East Jefferson Street, Fort Wayne, Indiana, has adopted and used the trade-mark shown in the accompanying drawing, for **CANDY**, in Class 46, Foods and ingredients of foods, and presents herewith five specimens showing the trade-mark as actually used by applicant upon the goods, and requests that the same be registered in the United States Patent Office in accordance with the act of February 20, 1905.
