TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT is entered into this 24th day of July 2002, by and between MOTOROLA, INC., a Delaware corporation (the "Assignor"), and AMERSHAM BIOSCIENCES AB, a corporation organized under the laws of Sweden (the "Assignee").

WHEREAS, the Assignor is the owner of certain rights in the trademarks as identified in the trademark applications listed in the attached Schedule (all such trademarks and trademark applications collectively referred to as the "Trademarks"); and

WHEREAS, the Assignee, is desirous of acquiring, and Assignor is desirous of assigning to Assignee all of its right, title and interest in and to the Trademarks.

NOW, THEREFORE, in consideration of the premises and of the mutual covenants and conditions herein contained and for other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties hereto hereby agree as follows:

1. Assignor hereby SELLS, ASSIGNS and CONVEYS unto Assignee all of its right, title, and interest to:
 - a. The Trademarks, including the good will associated therewith and all rights of priority thereto;
 - b. All rights of action to recover for past, present and future damages for infringement of said Trademarks; and
 - c. The right for the Assignee to register any of the Trademarks transferred to the Assignee in its own name.
2. Assignor shall cooperate with Assignee, at Assignee's request, to execute all documents and deeds that are reasonably necessary for giving full effect to the assignment contained herein.
