ARTICLES OF INCORPORATION**

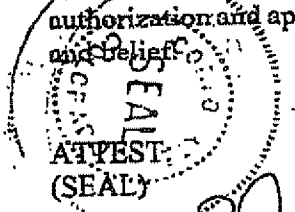
Change of Name

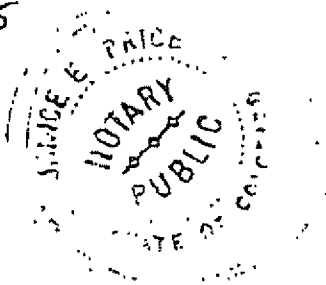
