TO THE  
ARTICLES OF INCORPORATION

Pursuant to the provisions of Section 10-1006 of the Arizona Revised Statutes, the undersigned Corporation adopts the following amendments to its Articles of Incorporation:

- I. The name of the Corporation is Parsons Advanced Holdings, Inc.
- II. The following sets forth the amendment to the following article:  
  
**FIRST: The name of the Corporation is The Go Daddy Group, Inc.**
- III. The amendment was adopted and approved by each of the Board of Directors and the shareholders on June 12, 2003.
