

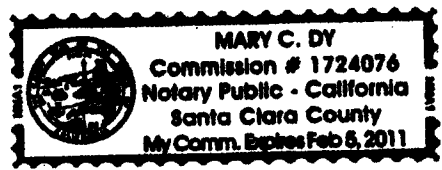
Assignee is the successor in interest with respect to the ongoing business of Assignor, or the portion of the business to which the Trademarks pertain.

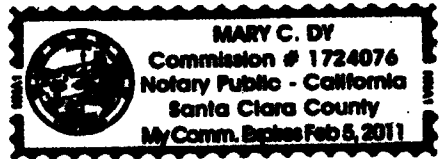
