RELEASE OF SECURITY INTEREST - TRADEMARKS

WHEREAS, G.V. Trademark Investments, Ltd, a British Virgin Islands corporation located at POB 3151 Road Town, Tortola, B.V.I. WHEREAS, Debtor is the owner of the Trademarks and the Property;

WHEREAS, the indebtedness secured by the Trademarks and the Property pursuant to the Security Agreement has been fully satisfied; and


WHEREAS, Secured Party now desires to release the Security Agreement and its security interest in the Property and the Trademarks;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Secured Party does hereby release Debtor from the Security Agreement and releases and discharges any and all interests and claims that Secured Party may have in the Property and in each of Debtor's Trademarks. Secured Party hereby declares that the Security Agreement is fully terminated and discharged and shall be of no further force and effect and that neither Secured Party nor Debtor shall have any further obligations thereunder. Secured Party further agrees that after the execution of this Release of Security Interest-Trademarks, Secured Party shall execute and deliver such other documents, including any power of attorney required for purposes

of recording this Release of Security Interest-Trademarks and take such other actions as may reasonably be requested in order to effectuate this Release.

IN WITNESS WHEREOF, Secured Party has caused this Release of Security Interests-Trademarks to be duly executed by its respective officers as of the 8<sup>th</sup> day of April, 2002.


