ATTESTATION TO GRANTOR ASSIGNMENT UNDER
TRADEMARK SECURITY AGREEMENTS

This Attestation to Grantor Assignment under Trademark Security Agreements is made as of May 21, 2009 by AXIA Incorporated, a Delaware corporation (the "Grantor"), as successor to Ames Taping Tool Systems Inc., a Delaware corporation (the "Original Grantor").

WHEREAS, the Original Grantor has heretofore granted to UBS AG, Stamford Brach ("UBS"), as Collateral Agent (in such capacity, the "Senior Collateral Agent") under and as defined in that certain Senior Trademark Security Agreement dated as of May 22, 2008 (the "Senior Trademark Security Agreement") by the Grantor and the Original Grantor in favor of the Senior Collateral Agent a security interest in TAPEMASTER U.S. Registration No. 2,199,221 (the "Trademark") to secure the Senior Obligations (as defined in the Senior Trademark Security Agreement);

WHEREAS, the Original Grantor has heretofore granted to UBS, as Collateral Agent (in such capacity, the "Subordinated Collateral Agent") under and as defined in that certain Subordinated Trademark Security Agreement dated as of May 22, 2008 (the "Subordinated Trademark Security Agreement" and, together with the Senior Trademark Security Agreement, the "Trademark Security Agreements") by the Grantor and the Original Grantor in favor of the Subordinated Collateral Agent a security interest in the Trademark to secure the Subordinated Obligations (as defined in the Subordinated Trademark Security Agreement);

WHEREAS, the Senior Collateral Agent has recorded its security interest in the Trademark by filing a copy of the Senior Trademark Security Agreement with the U.S. Patent and Trademark Office at Reel/Frame No. 3218/0542;

WHEREAS, the Subordinated Collateral Agent has recorded its security interest in the Trademark by filing a copy of the Subordinated Trademark Security Agreement with the U.S. Patent and Trademark Office at Reel/Frame No. 3797/0754; and


WHEREAS, an Assignment of the Trademark from the Original Grantor to the Grantor was recorded against the Trademark with the U.S. Patent and Trademark Office on October 27, 2008 at Reel/Frame No. 3877/0088.

NOW, THEREFORE, the Senior Collateral Agent, the Subordinated Collateral Agent and the Grantor wish to acknowledge the assignment of all rights in the Trademark from the Original Grantor to the Grantor, and the replacement of the Original Grantor by the Grantor in respect of the Trademark under each Trademark Security Agreement.




