

Pursuant to the provisions of the Alabama Business Corporation Act, the undersigned Corporation (the "Corporation") adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the Corporation is MARSHALL BISCUIT COMPANY, INC.

SECOND: The following amendment of the Articles of Incorporation was adopted by the Shareholders of the Corporation in the manner prescribed by the Alabama Business Corporation Act.

AMENDMENT

The Articles of Incorporation of MARSHALL BISCUIT COMPANY, INC. (f/k/a Outlaw Baking, Inc.) as recorded in Real Property Book 2800, Page 276, et seq. of the records in the Office of the Judge of Probate of Mobile County, Alabama, and as amended by Articles of Amendment recorded in Real Property Book 4117, Page 1010, be amended so as to make Article I of said Articles of Incorporation read as follows:

"ARTICLE I

The name of the Corporation shall be China Doll Rice and Beans, Inc."


THIRD: The date of the adoption of the amendment by the Shareholders was May 31, 2007.

FOURTH: The number of shares of the Corporation outstanding at the time of such adoption was 100; and the number of shares entitled to vote thereon 100.


FIFTH: The number of shares voted for such amendment was 100; and the number of shares voted against such amendment was zero (0).


