TRADEMARK ASSIGNMENT


TRADEMARK ASSIGNMENT made as of April 30, 2009 by and among Neoventa Medical AB, a Swedish corporation, with an address at Agatan 32, 431 35 Molndal, Sweden, SE-41346, and Neoventa Interim AB, a Swedish corporation, with an address at Agatan 32, 431 35 Molndal, Sweden (the "Assignee").

1. Assignor owns all right, title, and interest to United States Trademark Registration No. 2,511,348 for the mark STAN ("the Trademark"). Assignor wishes to assign all right, title, and interest to the Trademark to Assignee.
