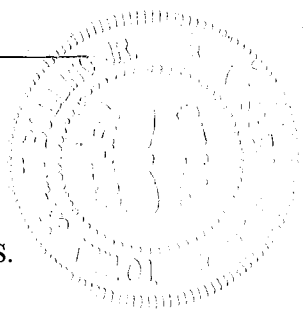
WHEREAS, Assignee desires to acquire the Trademark; and
