OWNER'S REGISTRATION UNDER
TMEP § 503.06(c)**

DECLARATION UNDER 37 CFR §2.20

The undersigned being hereby warned that willful false statements and the like so made are punishable by fine or imprisonment, or both, under 18 U.S.C. 1001, and that such willful false statements may jeopardize the validity of the registration, declares that:

- (1) he is an officer or owner of the Registrant identified in the above-identified registration and is properly authorized to execute this declaration;
- (2) Agri-King, Inc., is the proper owner of Registration No. 2,374,452 for the mark AGRI-KING;
- (3) the previously recorded Assignment of a Security Interest recorded on February 4, 2004 and located at Reel/Frame 2909/0862 between Lee Wayne Corporation and GMAC Commercial Finance, LLC was erroneously recorded, as Lee Wayne Corporation has never had any right, title or interest in the mark AGRI-KING;
- (4) GMAC Commercial Finance, LLC admitted to the erroneous recordation of said security interest in the mark AGRI-KING in Schedule 1 of the Release by Secured Party recorded on April 30, 2009 and located at Reel/Frame 3980/0432;
- (5) the previously recorded Release by Secured Party recorded on April 30, 2009 and located at Reel/Frame 3980/0432 between GMAC Commercial Finance,

LLC and Lee Wayne Corporation properly releases the erroneously recorded security interest, however improperly identifies Lee Wayne Corporation as the Assignee of the mark AGRI-KING, as Lee Wayne Corporation has never had any right, title or interest in the mark AGRI-KING;

- (6) Agri-King, Inc. has continuously owned the entire right, title and interest in and to the mark AGRI-KING and at no time assigned, sold or otherwise transferred any right, title or interest in the mark AGRI-KING to either Lee Wayne Corporation or GMAC Commercial Finance, LLC;
- (7) Agri-King, Inc., the original registrant, has been and continues to be the owner of Registration No. 2,374,452 for the mark AGRI-KING;

and all statements made of his own knowledge are true and all statements made on information and belief are believed to be true.
