
As set for in the Trademark Assignment Abstract of Title, the following is believed to be the True Chain of Title for these registrations:

4. On January 9, 2009 a correction in to the name and address of the Assignee for the change of name recorded at Reel/Frame: 003915/0768 was requested. The correction was recorded on January 9, 2009 at Reel/Frame: 003916/0318.
5. On March 9, 2009 a correction to the address of the Assignee for the correction of the change of name recorded at Reel/Frame: 003916/0318 was requested. The correction was recorded on March 9, 2009 at Reel/Frame: 003948/0636.

The last correct assignee, E-Risk Services, L.L.C. has been and continues to be the owner of the above registrations.
