**ASSIGNMENT AND ASSUMPTION AGREEMENT  
(INTELLECTUAL PROPERTY)**

This Assignment and Assumption Agreement (this "Assignment") is made by and between Blethen Maine Newspapers, Inc., a Washington corporation, whose address is 390 Congress Street, Portland, Maine 04101 ("Seller"), and MaineToday Media, Inc., a Delaware corporation, whose address is c/o HM Capital Partners, LLC, 200 Crescent Court, Suite 1600, Dallas, Texas 75201 ("Buyer"), in connection with the closing of the transactions contemplated by that certain Asset Purchase Agreement dated as of June [16], 2009, between Seller and Buyer (the "Purchase Agreement," with capitalized terms used but not defined herein having the meanings given to them in the Purchase Agreement).

In consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound, Buyer and Seller hereby agree as follows:

1. Upon the terms and subject to the conditions of the Purchase Agreement, Seller hereby assigns to Buyer of all of Seller's right, title and interest in and to the Acquired Intellectual Property, including without limitation, the trademark registrations and copyright registrations listed in Schedules 1 and 2 attached hereto, together with Seller's goodwill primarily associated with any of such Acquired Intellectual Property. The assignment contemplated herein does not include rights to claims that are Excluded Assets, and any causes of action or remedies related thereto.

2. Buyer hereby accepts the assignment in Section 1 hereof and, from and after the date hereof, will assume, perform, and discharge all liabilities and obligations of Seller relating to such Acquired Intellectual Property that accrue after the Closing.

3. This Assignment shall be governed by and construed in accordance with the laws of the State of Maine without giving effect to the conflict of laws principles thereof.

4. None of the provisions of this Assignment may be waived, changed or altered except in a signed writing by the party against whom enforcement of the same is sought.


5. Notwithstanding anything to the contrary, nothing herein is intended to, nor shall it, extend, amplify or otherwise alter the representations, warranties, covenants and obligations of the parties contained in the Purchase Agreement or the survival thereof. In the event of a conflict between the terms and conditions of this Assignment and the terms and conditions of the Purchase Agreement, the terms and conditions of the Purchase Agreement shall govern, supersede and prevail.

6. This Assignment may be executed in one or more counterparts, each of which will be deemed to be an original and all of which, when taken together, will be deemed to constitute one and the same agreement. The exchange of copies of this Assignment and of signature pages by facsimile transmission or scanned copy and email shall constitute effective execution and delivery of this Assignment.
