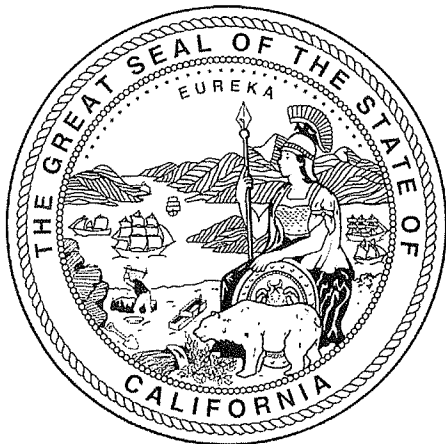

2. Article ONE of the Articles of Incorporation of this corporation, is amended in order to change the corporation's name, to read as follows:

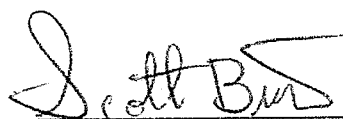
ONE: The name of this corporation is:
