IN UNITED STATES TRADEMARKS**

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, Houghton Technical Corporation, a Delaware corporation (the "Grantor") with principal offices at 300 Delaware Avenue, Suite 316, Wilmington, Delaware 19801, hereby grants to The Governor and Company of the Bank of Ireland, as Collateral Agent, with principal offices at Bank of Ireland Corporate Banking, Head Office, B-2, Lower Baggot Street, Dublin 2, Republic of Ireland (the "Grantee"), a continuing security interest in (i) all of the Grantor's right, title and interest in, to and under to the United States trademark, trademark registration and trademark application (the "Mark") set forth on Schedule A attached hereto, (ii) all Proceeds (as such term is defined in the Guaranty and Collateral Agreement referred to below) and products of the Mark, (iii) the goodwill of the businesses with which the Mark is associated and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Mark or unfair competition regarding the same; it being understood that with respect to United States intent-to-use trademark applications included in the Trademark, the grant of the security interest hereunder shall not apply until and unless a statement of use or an amendment to allege use has been filed and accepted by the United States Patent and Trademark Office.



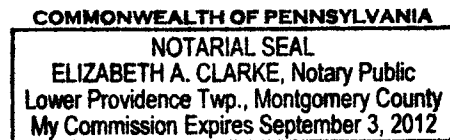
