RELEASE OF SECURITY INTEREST IN TRADEMARKS

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party does hereby release its security interest in the Trademarks, and discharges, quit claims and relinquishes unto Grantor (in each case without recourse and without representation or warranty) any and all rights, title and interest it has in and to the Trademarks.
