ARTICLES OF INCORPORATION

2. Article I of the Articles of Incorporation of this Corporation is amended to read as follows:

"I

The name of this Corporation is DAVSTAR, INC."

3. The foregoing amendment of the Articles of Incorporation have been approved by the Board of Directors.

4. The foregoing amendment of Articles of Incorporation have been approved by the required vote of the shareholders in accordance with Section 902, 903 and 905 of the Corporations code. The total number of outstanding shares of the Corporation at the time of the vote was 100,000 shares of capital stock. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50%.

5. We further declare under penalty of perjury under the laws of the State of California that the matters set forth in this Certificate are true and correct of our own knowledge.
