

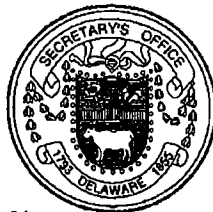



BCSI INC., a Delaware corporation

BCSI Inc. ("BCSI"), a corporation organized and existing under the laws of the State of Delaware, pursuant to Section 253 of the Delaware General Corporation Law ("DGCL"), **DOES HEREBY CERTIFY** as follows:

FIRST: BCSI was incorporated on the 15th day of September, 1994, pursuant to the provisions of the DGCL;

SECOND: BCSI owns 100% of the stock of Cincinnati Bell Technology Solutions Inc. ("CBTS"), a corporation incorporated on the 6th day of January, 1998 A.D., pursuant to the laws of Ohio;

THIRD: The Board of Directors of BCSI, pursuant to Sections 141(f) and 253 of the DGCL adopted the following resolutions on the 19th day of December, 2005 A.D.:

WHEREAS, the Company lawfully owns 100% of the outstanding stock of Cincinnati Bell Technology Solutions Inc. ("CBTS"), a corporation formed and existing under the laws of Ohio; and

WHEREAS, the Company desires to merge CBTS into the Company, and to be possessed of all the estate, property, rights, privileges and franchises of CBTS;

NOW, THEREFORE, BE IT RESOLVED, that CBTS shall be merged with and into the Company pursuant to Section 253 of the DGCL, to be effective upon the filing of the Certificate of Ownership with the Delaware Secretary of State, and that the Company shall assume all of the estate, assets, liabilities, obligations, reserves, property, rights, privileges, accounts and franchises of CBTS;

FURTHER RESOLVED, that the Company relinquishes its corporate name and assumes in place thereof the name Cincinnati Bell Technology Solutions Inc.
