"The purpose of this corporation is to engage in the profession of medicine and any other lawful activities (other than banking or trust company business) not prohibited to a corporation engaging in such profession by applicable laws and regulations."
4. The foregoing amendment of the articles of incorporation of this corporation has been duly approved by the Corporation's Board of Directors.

The foregoing amendment of the articles of incorporation of this Corporation has been duly approved by the required vote of shareholders in accordance with Section 902 of the California Corporations Code. The total number of issued and outstanding shares entitled to vote with respect to the amendment is one hundred (100). The total number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50%.

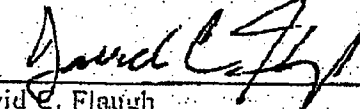
