**ASSIGNMENT OF SECURITY INTEREST
(TRADEMARK)**

This Assignment of Security Interest is made effective as of May 13, 2009 by and between Finisar Corporation ("Assignor") and Laser Operations LLC ("Assignee").

WHEREAS, pursuant to that certain Collateral Assignment of Trademark, dated as of October 11, 2006 between Assignor and Quintessence Photonics Corporation ("QPC"), QPC granted a security interest (the "Security Interest") in and all QPC's right, title and interest in and to each of the trademarks listed on Schedule A (collectively referred to as the "Trademark Collateral");

WHEREAS, this Assignment is being executed in connection with a certain Loan Sale Agreement dated May 12, 2009, between Assignor and Assignee pursuant to which Assignee is acquiring the loan obligations owing from QPC to Assignor which the Security Interest secures;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are acknowledged, Assignor assigns to Assignee all right, title and interest in and to the Security Interest in the Trademark Collateral, including, but not limited to, all common law and other rights (but in no event any of the obligations) in and to the Trademark Collateral in the United States and any state thereof and in foreign countries, all goodwill of QPC's business symbolized by the Trademark Collateral and associated therewith, all proceeds, products, rents and profits of or from any and all of the foregoing Trademark Collateral and, to the extent not otherwise included, all payments under insurance (whether or not Assignee is the loss payee thereof), or any indemnity, warranty or guaranty, payable by reason of loss or damage to or otherwise with respect to any of the foregoing Trademark Collateral

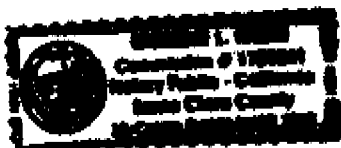

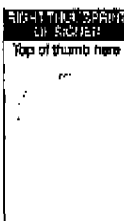
