**TERMINATION AND RELEASE OF SECURITY INTEREST
IN UNITED STATES TRADEMARKS**

TERMINATION AND RELEASE dated as of June 5, 2009, from GS Canada Specialty Lending Company, as agent (in such capacity, the "Agent"), for several banks and other financial institutions or entities to Shred-It Canada Corporation Inc. (the "Grantor").

WITNESSETH:

WHEREAS, pursuant to a Trademark Security Agreement dated as of August 28, 2007 in favor of the Agent (the "Security Agreement"), a security interest (the "Security Interest") was granted by the Grantor to the Agent in the Trademark Collateral (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office, at Reel 3629 Frame 0173; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Exhibit A hereto.

2. Release of Security Interest. The Agent hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of the Agent in such Trademark Collateral shall hereby cease and become void.
