ASSIGNMENT OF TRADEMARK

Whereas, Decru, Inc., ("Assignor"), a Delaware corporation, owns the marks OPENKEY, CRYPTOSHRED, DECRU, CRYPTAINER and DECRU DATAFORT (hereinafter "Marks") in the United States and other countries, and specifically as to the intent-to-use application for the mark OPENKEY in the United States, owns the OPENKEY intent-to-use application and has the requisite good faith intent to use the OPENKEY mark in commerce in the United States (hereinafter "OPENKEY Application"), and the Marks that have otherwise been applied-for or registered in the countries identified on the attached Exhibits A and B.

Now, therefore, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor assigns to Assignee all its right, title and interest in and to the Marks, together with the goodwill of the business symbolized by the Marks, all registrations listed on Exhibits A and B, and, for the OPENKEY Application, Assignor assigns to Assignee all its right, title and interest in the OPENKEY Application, together with that portion of the business symbolized by the OPENKEY Application, and for all other applications listed on the attached Exhibits A and B, Assignor assigns all its right, title and interest to the applications, together with the business symbolized by the applications. This assignment includes the right to sue and recover damages for past and future infringements of Assignor's rights in the Marks and to bring any proceeding in the United States Patent and Trademark Office or any equivalent authority in any other country for cancellation or opposition or any other proceeding in connection with said Marks. The right, title and interest is to be held and enjoyed by Assignee and Assignee's successors and assigns as fully and exclusively as it would have been held and enjoyed by Assignor had this assignment not been made.

Assignor further agrees that it will execute, verify, acknowledge and deliver all such further papers, including any instruments of transfer and recordable assignments, and perform such other acts as Assignee lawfully may request from time to time, to perfect and vest title in the Mark in Assignee, or Assignee's successors and assigns.


