Assignor hereby agrees to cooperate with Assignee as reasonably necessary to give full effect to and perfect the rights of Assignee in the Trademark. Assignor hereby covenants and agrees to and with Assignee, its successors, legal representatives and assigns that Assignor will sign and deliver all certificates, instruments, papers and documents, make all lawful affidavits, testimonies, declarations and oaths, and do all acts necessary or required to be done for the recordation of this assignment of the Trademark to the Assignee.

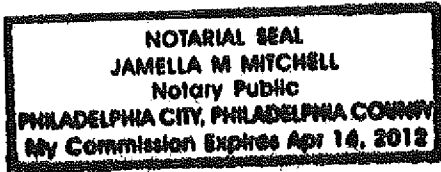
