STATEMENT OF CHANGE OF NAME

1. I, Frank J. Freiler, am a Directeur Général of Engelhard Lyon SA, formerly Coletica SA, having offices at 32, rue Saint Jean de Dieu, 69007 Lyon, France.
2. On June 30, 2005 by resolution of its Board of Directors, Coletica changed its name to Engelhard Lyon. An extract of the minutes of the Board of Director's meeting evidencing this resolution is attached in the French language (see e.g. the "Quinzieme Resolution" in the attached minutes).
3. The change of name was subsequently registered with the Gieffe du Tribunal de Commerce on September 5, 2005. A copy of the registration for Coletica, dated April 7, 2005, and the subsequent registration for Engelhard Lyon of September 5, 2005 are attached hereto to evidence that Registration No. 333 802 767 RCS Lyon is now in the name of Engelhard Lyon.


