**RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

HMH Publishers LLC, a Delaware limited liability company (the "Assignor"), among others, executed a First Lien Trademark Security Agreement dated as of December 12, 2007 (the "Agreement") in favor of Credit Suisse, Cayman Islands Branch, as collateral agent (the "Collateral Agent"), which Agreement was duly recorded on January 11, 2008 in Reel 3696, Frame 0255 in the United States Patent and Trademark Office pursuant to which the Assignor assigned and granted to the Agent a security interest (the "Security Interest") in and to all of the Assignor's right, title and interest in and to the Assets, as defined in the Asset Purchase Agreement, dated May 31, 2009 among Houghton Mifflin Harcourt Publishing Company, the Assignor and Our Sunday Visitor, Inc., including, but not limited to, certain trademarks listed on Exhibit A attached hereto (the "Released Trademarks") and the goodwill associated therewith.

For good and valuable consideration, receipt of which is hereby acknowledged, the Agent without recourse, representation or warranty and at the Assignor's sole cost and expense, hereby irrevocably releases, terminates and discharges the entirety of the Security Interest in the Released Trademarks and transfers and assigns to the Assignor, without representation or warranty of any kind, express or implied, all of the Agent's right, title and interest in and to the Released Trademarks and the goodwill associated therewith.

The Agent hereby agrees to duly execute, acknowledge and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest in the Released Trademarks.
