Nunc Pro Tunc Trademark Assignment

This Assignment made this 24th day of June, 2009, effective the 29th day of June, 1995, by and between SKF USA Inc., a Delaware corporation, having an address of 890 Forty Foot Road, PO Box 332, Kulpsville, PA 19443 (hereinafter "Assignor"), and Waldes Truarc Inc., a Delaware corporation, having an address of Suite L-100, 32 Lookerman Square, Dover, Delaware 19904 (hereinafter "Assignee").

WHEREAS, as of June 28, 1995, Assignor was the owner of United States Trademark Registration No. 1,001,237 for the mark TRUARC (hereinafter the "Mark");

WHEREAS, Assignee was desirous of acquiring all of Assignor's rights in and to the Mark, including any and all common law rights in connection therewith;

WHEREAS, pursuant to and as set forth in that certain Asset Purchase Agreement between Assignor and Assignee dated June 29, 1995, Assignor assigned the Mark to Assignee; and

WHEREAS, Assignor and Assignee are desirous of further memorializing such assignment;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor agrees that Assignor hereby assigned unto Assignee, *nunc pro tunc* as of June 29, 1995, all right, title and interest in and to the Mark throughout the world, together with the goodwill of the business in connection with which the Mark is used, along with the right to sue and recover for damages and profits for past infringements thereof.

Assignor agrees to execute and deliver at the request of the Assignee, all papers, instruments, and assignments, and to perform any other reasonable acts the Assignee may require in order to vest all of Assignor's rights, title, and interest in and to the Mark in the Assignee and/or to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by the Assignee, to the extent such evidence is in the possession or control of Assignor, which shall include, without limitation, execution of any forms, statements or other documents required by any trademark office relating to the Mark. Notwithstanding the foregoing, Assignee shall be exclusively responsible for any fees or payments to third parties arising from such efforts.
