TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of June 30, 2009, by MCG Capital Corporation, as Administrative Agent ("MCG").

WITNESSETH:

WHEREAS, MCG and CERVALIS LLC, a Delaware limited liability company ("CERVALIS"), were parties to a Security Agreement dated as of March 15, 2007, pursuant to which CERVALIS granted a security interest to MCG in certain trademarks (the "Trademarks") and Trademark Rights (as defined below) as security for certain obligations owing by CERVALIS to MCG, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the notice of grant of security interest was recorded by the Trademark Division of the United States Patent and Trademark Office on March 22, 2007, at Reel 3505, Frame 0273; and

WHEREAS, CERVALIS has requested that MCG release its security interest in the Trademarks and Trademark Rights and reassign the same to CERVALIS.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. MCG hereby releases its security interest in all of CERVALIS's right, title and interest in and to the following (collectively the "Trademark Rights"):

(i) each Trademark listed on Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and


(ii) all products and proceeds of the foregoing, including without limitation, any claim by CERVALIS against third parties for past, present or future (a) infringement or dilution of any Trademark, or (b) injury to the goodwill associated with any Trademark.

2. MCG hereby reassigns, grants and conveys to CERVALIS, without any representation, recourse or undertaking by MCG, all of MCG's right, title and interest in and to the Trademarks and the Trademark Rights.
