**RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS**

THIS RELEASE is made as of this 30 day of June, 2009, by The Royal Bank of Scotland plc, as Security Trustee ("RBS"), in favor of Calumet Photographic, Inc., a Delaware corporation (the "Company").

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, RBS hereby unconditionally and expressly releases, terminates, and extinguishes any and all of its right, title and interest in and to any and all liens and security interests it may have upon the trademarks, trademark applications and trademark licenses listed on Schedule A (the "Trademarks") attached hereto and made a part hereof, along with all goodwill associated therewith and all products and proceeds of the foregoing and all damages for past infringement thereof, which liens and security interests were established under and pursuant to that certain Grant of Security Interest in United States Patents and Trademarks, dated as of February 24, 2006, by the Company in favor of RBS (the "Security Grant"), said Security Grant having been recorded in the U.S. Patent and Trademark Office on March 15, 2006, at Reel 017303, Frame 0515.

Any and all rights of RBS in the Trademarks are hereby unconditionally and expressly assigned to the Company, and the Company presently and hereafter holds title to the Trademarks in the same manner as would have been the case if the Security Grant had never been entered into.


Any provision of this Release which is invalid, illegal, or unenforceable in any jurisdiction shall, as to that jurisdiction, be ineffective only to the extent of such invalidity, illegality, or unenforceability, and shall not in any manner affect the remaining provisions hereof in such jurisdiction or render any other provision of this Release invalid, illegal, or

unenforceable in any other jurisdiction. RBS consents and agrees to execute and deliver, at the request and cost of the Company, such further instruments, documents and release forms as the Company may reasonably request to more effectively, release, terminate and extinguish any such liens and security interests upon the Trademarks.

This Release shall be binding upon RBS's legal representatives, assigns and successors, and shall inure to the benefit of the Company and the Company's heirs, administrators, successors and assigns.
