GRANT OF SECURITY INTEREST IN TRADEMARKS

This Grant of Security Interest in Trademarks, dated as of June 30, 2009, is made between Composite Technology Corporation, a Nevada corporation, having a place of business at 2026 McGaw Avenue, Irvine, California 92614 (the "Grantor") and Northlight Financial LLC, a Delaware limited liability company, individually and in its capacity as Collateral Agent, having a place of business at 24 West 40th Street, 12th Floor, New York, New York 10018 (the "Secured Party");

WHEREAS, Grantor is the owner of the trademarks applications and registrations identified on Schedule A attached hereto (collectively the "Trademarks"); and

WHEREAS, Grantor is obligated to Secured Party under the terms of a certain Security Agreement among Grantor and the Secured Party dated as of June 30, 2009 (the "Security Agreement");

NOW THEREFORE, pursuant to the Security Agreement and in order to induce the Secured Party to enter into the Security Agreement, Grantor does hereby grant Secured Party a security interest in all Grantor's right, title and interest in and to: (i) the Trademarks, including all applications or registrations therefor; (ii) all income, royalties, damages and payments now due or payable or which hereafter become due or payable in respect to thereto; (iii) all causes of action (in law or equity) and rights to sue, counterclaim and/or recover for past, present or future infringement thereof; and (iv) all rights corresponding to the foregoing throughout the world.


