## AFFIDAVIT and NUNC PRO TUNC ASSIGNMENT

I, Marie-Cecile Moins, am Associate General Counsel of Thomson, a *société anonyme* organized and existing under the laws of France, located and doing business at 46, quai Alphonse Le Gallo, 92100 Boulogne-Billancourt, France ("THOMSON"), and Associate General Counsel of Thomson, Inc., a Delaware corporation, located and doing business at 10330 North Meridian Street, Indianapolis, Indiana 46290-1024 ("THOMSON INC."). THOMSON INC. is a wholly-owned subsidiary of THOMSON. I am authorized to execute this document, and have first-hand knowledge of the facts recited below;

I, Philippe Andrau, am Group General Counsel of THOMSON, and also Group General Counsel of THOMSON INC. I am authorized to execute this document, and have first-hand knowledge of the facts recited below:

Nextream France, a *société anonyme* organized and existing under the laws of France ("NEXTREAM"), the owner of record of the trademarks listed in the attached Schedule, was a wholly-owned subsidiary of THOMSON;

On or about the 1st day of May, 2006, NEXTREAM ("ASSIGNOR") did assign and transfer unto Grass Valley, Inc. ("GRASS VALLEY"), a Delaware corporation, located and doing business at 400 Providence Mine Road, Nevada City, California 95969-7900 U.S.A. ("ASSIGNEE"), all of its right, title and interest in and to the trademarks listed on the attached Schedule and the registrations thereof in the United States of America, together with the goodwill of the business associated with said trademarks, and the right to sue for damages and profits and all other past and future infringements thereof;

On or about the 1<sup>st</sup> day of May, 2006, NEXTREAM also did assign and transfer unto GRASS VALLEY all agreements pertaining to NEXTREAM's trademarks, and especially, all obligations and benefits of a Co-Existence Agreement between NEXTREAM and Western Reserve Controls, Inc., dated February 24, 2006, pertaining to NEXTREAM's United States trademark application Ser. No. 78/453,215 SMARTMUX, and governing any subsequent filings of a trademark application for VIBE SMARTMUX;

NEXTREAM was dissolved on May 5, 2006, and is no longer in existence;

GRASS VALLEY was a wholly-owned subsidiary of THOMSON INC. Effective December 31, 2008, GRASS VALLEY was merged into THOMSON INC. and is no longer in existence.

WHEREAS, the parties are desirous of confirming said assignment of trademarks from NEXTREAM to GRASS VALLEY, and of recording the same, *nunc pro tunc*, in the United States Patent and Trademark Office;

NOW THEREFORE, ASSIGNOR's parent company, THOMSON, and ASSIGNEE's parent company and successor, THOMSON INC., both hereby confirm this assignment by their undersigned duly authorized officers, and request that the assignment be recorded, *nunc pro tunc*, in the United States Patent and Trademark Office.
