SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS SECURITY INTEREST IN INTELLECTUAL PROPERTY ("IP Security Interest"), dated as of July 2, 2009, is made by and among (i) HIGHWAY TO HEALTH, INC., D/B/A HTH WORLDWIDE, a Delaware corporation (the "Issuer"); (ii) WORLDWIDE INSURANCE SERVICES, INC., a Virginia corporation ("Worldwide"); (iii) each other Subsidiary of the Issuer that may from time to time become a party hereto (together with the Issuer and Worldwide, the "Grantors" and each a "Grantor"); and (iv) SWISS REINSURANCE COMPANY LTD (the "Holder"), pursuant to the Security Agreement (defined below).

WHEREAS, pursuant to that certain Promissory Note by the Issuer in favor of the Holder (as amended, restated, supplemented or otherwise modified from time to time, the "Note") the Holder has agreed to purchase the Note from the Issuer;

WHEREAS, in connection with the Note, the Grantors executed and delivered to the Holder a Security Agreement dated July 2, 2009 (together with all amendments and other modifications, if any, from time to time thereafter made thereto, the "Security Agreement"), pursuant to which the Grantors granted a security interest in the Intellectual Property Collateral to the Holder;

WHEREAS, as a condition precedent to the purchase of the Note, and in conjunction with the Security Agreement, Grantors are obligated to execute and deliver this IP Security Interest; and

WHEREAS, Grantors have duly authorized the execution, delivery and performance of this IP Security Interest.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Grantors agree as follows:

Section 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this IP Security Interest, including its preamble and recitals, have the meanings provided or provided by reference in the Security Agreement or the Note (collectively, the "Finance Documents").

Section 2. Grant of Security Interest. As security for the full and timely payment, observance and performance of the obligations pursuant to the Finance Documents, Grantors hereby grant to Holder a continuing security interest in and a right of setoff against, all of Grantors' right, title and interest in, to and under the Intellectual Property, including, without limitation: (i) the trademark applications and trademark registrations listed on Schedule A attached hereto; (ii) the patents and patent applications listed on Schedule B attached hereto, and (iii) the copyrights and copyright applications listed on Schedule C attached hereto.

Section 3. Purpose. This IP Security Interest has been executed and delivered by Grantors for the purpose of recording at the United States Patent and Trademark Office and

at the United States Copyright Office the security interest granted in the Finance Documents. The security interest granted hereby has been granted, pursuant to the Security Agreement, as a supplement and ancillary to, and not in limitation of, the security interest granted to Holder under the Security Agreement with respect to the Intellectual Property Collateral. The Security Agreement (and all rights and remedies of Holder thereunder) shall remain in full force and effect in accordance with its respective terms. In the event of any conflict between this IP Security Interest and the Finance Documents, the Finance Documents shall prevail.



Grantors hereby further acknowledge and affirm that the rights and remedies of Holder with respect to the security interest granted hereby are more fully set forth in the Finance Documents, the terms and provisions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein.

Section 5. Counterparts. This Security Interest In Intellectual Property may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.




