BILL OF SALE AND ASSIGNMENT AND ASSUMPTION AGREEMENT

This BILL OF SALE AND ASSIGNMENT AND ASSUMPTION AGREEMENT (this “Agreement”), is dated as of May 20, 2009, by and between Whitford Worldwide Company, a Delaware corporation (“Purchaser”), and/or its nominee(s) and Akzo Nobel Coatings Inc., a Delaware corporation, and Akzo Nobel Coatings International B.V., a corporation organized under the laws of the Netherlands (collectively, the “Sellers”).

WHEREAS, Purchaser and Akzo Nobel Coatings International B.V. (“ANCIBV”), Seller’s parent company, are parties to an Asset Purchase Agreement, dated as of January 15, 2009 (as amended, the “Purchase Agreement”) under which ANCIBV and/or Affiliates including Sellers, has sold to Purchaser certain assets. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Purchase Agreement.

WHEREAS, Sellers and Purchaser have agreed, pursuant to the Purchase Agreement, to execute and deliver, or to procure the execution and delivery of, this Agreement for the purpose of transferring to and vesting in Purchaser title to the Acquired Assets held by Sellers as set forth herein.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. Effective as of the date hereof, and in consideration of the covenants, agreements, provisions, and terms of the Purchase Agreement, and in all cases subject to the terms thereof, Sellers hereby sell and deliver to Purchaser, and Purchaser hereby purchases from Sellers, all of Seller’s right, title, and interest in and to the Acquired Assets held by Sellers, free and clear of all liens, and all rights, claims, credits, warranty rights, causes of action or rights of set-off related to such Acquired Assets arising after the Closing Date.

2. Purchaser hereby assumes and agrees to discharge and perform the Assumed Liabilities.

3. This Agreement shall be binding on and inure to the benefit of and be enforceable by the parties hereto and their respective successors and assigns.

4. This Agreement is subject to the terms and conditions of the Purchase Agreement and shall be governed and enforced in accordance with the laws of the Commonwealth of Pennsylvania applicable to agreements made and to be performed entirely within such State, without regard to the conflicts of law principles of such State.

5. Nothing in this Agreement shall alter any liability or obligation of Purchaser or Seller arising under the terms and conditions of the Purchase Agreement, which shall govern the representations, warranties, covenants, agreements and obligations of the parties with respect to the Acquired Assets and the Assumed Liabilities.

6. This Agreement may be executed in counterparts, each of which shall be deemed an original and all of which, when taken together, shall constitute one and the same instrument.

7. This Agreement may be executed by facsimile signature or Portable Document Format ("PDF") and a facsimile signature or PDF shall constitute an original signature for all purposes.



ASSET PURCHASE AGREEMENT

This ASSET PURCHASE AGREEMENT ("Agreement") is dated this 15th day of January, 2009, by and between Whitford Worldwide Company, a Delaware corporation, with a place of business at 47 Park Avenue, Elverson, Pennsylvania 19520, United States ("Purchaser"), and/or its nominee(s) and Akzo Nobel Coatings International B.V., a corporation organized under the laws of the Netherlands, with a place of business at Velperweg 76, Arnhem, 6824 BM The Netherlands ("Seller"), and/or its Affiliates .

RECITALS

WHEREAS, Seller, itself or through its Affiliates, owns various properties, interests and assets which are used exclusively in the Seller's non-stick coating business unit for (i) liquid non-stick coating and (ii) powder non-stick coating for cookware and bakeware throughout the world, including without limitation, at those locations set forth on Exhibit "A" attached hereto (collectively, the "Business"); and

WHEREAS, Purchaser and Seller have determined that it is advisable and in their best interests that Purchaser purchase the Acquired Assets (as hereinafter defined) constituting the Business, and Seller sell such Acquired Assets to Purchaser, upon the terms and subject to the conditions set forth herein.

NOW, THEREFORE, in consideration of the recitals herein before stated and the mutual representations, warranties, covenants and agreements hereinafter set forth, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, Purchaser and Seller agree as follows:

SECTION 1

DEFINITIONS

1.1 Defined Terms. In addition to the terms defined elsewhere in this Agreement, the following terms when utilized in this Agreement, unless the context otherwise requires, shall have the meanings indicated, which meanings shall be equally applicable to both the singular and plural forms of such terms:

"Accounting Principles" is defined in Section 3.1(a) of this Agreement.

"Acquired Assets" is defined in Section 2.1 of this Agreement.

"Affiliate" with respect to any Person means any Person who, directly or indirectly, through one or more intermediaries, controls the subject Person or any Person which is controlled by or is under common control with a controlling Person. For purposes of this definition, "control" (including the correlative terms "controlling", "controlled by" and "under common control with"), with respect to any Person, means possession, directly or indirectly, of the power to direct or cause the direction of the management and policies of such Person, whether through the ownership of voting securities or by contract or otherwise.

"Agreement" means this Asset Purchase Agreement, together with all schedules and exhibits contemplated hereby.

"AN India" is defined in Section 2.1(a) of this Agreement.

"Assumed Contracts" is defined in Section 2.1(e) of this Agreement.

"Assumed Liabilities" is defined in Section 4.2 of this Agreement.

"Bill of Sale" is defined in Section 10.1(a) of this Agreement.

"Business" is defined in the recitals to this Agreement.

"Business Day" means any day of the year on which banking institutions located in the Commonwealth of Pennsylvania are open to the public for the conduct of business, excluding Saturdays and Sundays.

"Business Employee" is defined in Section 12.4 of this Agreement.

"Closing" is defined in Section 5 of this Agreement.

"Closing Certificate" is defined in Section 3.2(a) of this Agreement.

"Closing Date" is defined in Section 5 of this Agreement.

"Code" means the United States Internal Revenue Code of 1986, as amended.

"Dollars" means United States dollars.

"Employee Benefit Plan" means any (i) nonqualified deferred compensation or retirement plan or arrangement which is an Employee Pension Benefit Plan, (ii) defined contribution retirement plan or arrangement which is an Employee Pension Benefit Plan intended to be qualified under Section 401(a) of the Code, (iii) defined benefit retirement

plan or arrangement which is an Employee Pension Benefit Plan intended to be qualified under Section 401(a) of the Code, or (iv) Employee Welfare Benefit Plan.

"Employee Pension Benefit Plan" has the meaning set forth in ERISA Section 3(2).

"Employee Welfare Benefit Plan" has the meaning set forth in ERISA Section 3(1).

"Environmental Laws" is defined in Section 6.10 of this Agreement.

"ERISA" means the Employee Retirement Income Security Act of 1974, as amended, and the regulations promulgated thereunder.

"Europe" is defined in Section 15.10 of this Agreement.

"Euros" means the official currency of the European Union's member nations.

"Excluded Assets" is defined in Section 2.2 of this Agreement.

"Excluded Liabilities" is defined in Section 4.1 of this Agreement.

"Fixed Purchase Price" is defined in Section 3.1 of this Agreement.

"Foreign Employee Regulation" means any Law in any jurisdiction worldwide concerning the employment or termination of any employees of the Business as a result of the Transaction.

"Governmental Authority" means any government, court, regulatory or administrative agency or commission, or other governmental authority, agency or instrumentality, whether federal, state or local (domestic or foreign).

"IFRS" means the International Financial Reporting Standards currently in effect.

"Intellectual Property" means (i) United States, international, and foreign patents and patent applications, including divisionals, continuations, continuations-in-part, reissues, reexaminations, and extensions thereof and counterparts claiming priority therefrom; utility models; invention disclosures; and statutory invention registrations and certificates; (ii) United States and foreign registered, pending, and unregistered trademarks, service marks, trade dress, logos, trade names, corporate names and other source identifiers, domain names, Internet sites and web pages; and registrations and applications for registration for any of the foregoing, together with all of the goodwill associated therewith; (iii) United States and foreign copyrights, and registrations and

applications for registration thereof; rights of publicity; and copyrightable works; (iv) all inventions and design rights (whether patentable or unpatentable) and all categories of trade secrets as defined in the Uniform Trade Secrets Act, including business, technical and financial information; and (v) proprietary information, including research data and know-how.

“Inventory” means raw materials, packaging, work in process and finished goods each in usable, saleable or reworkable condition in existence on the Closing Date relating exclusively to the Business which includes any such materials or goods held by AN India.

“Inventory Excess” is defined in Section 3.2(a) of this Agreement.

“Inventory Purchase Price” is defined in Section 3.1 of this Agreement.

“Inventory Shortfall” is defined in Section 3.2(a) of this Agreement.

“IRS” means the United States Internal Revenue Service.

“Law” means any foreign, federal, state or local statute, law, rule, ordinance, code or regulation, any Order, and any regulation, rule, interpretation, guidance or directive of any Governmental Authority.

“Leased Real Property” is defined in Section 6.9(a) of this Agreement.

“License Agreement” is defined in Section 2.2(c) of this Agreement.

“Lien” means any lien, charge, claim, restriction, encumbrance, security interest or pledge of any kind whatsoever.

“Local Transfer Agreements” is defined in Section 10.1(f) of this Agreement.

“Losses” is defined in Section 13.2 of this Agreement.

“Material Adverse Effect” means a material adverse effect on the business, assets, properties, results of operations or financial condition of the Business taken as a whole.

“Material Adverse Effect on Purchaser” means (i) a material adverse effect on the business, assets, properties, results of operations or financial condition of Purchaser or (ii) a material adverse effect on Purchaser's ability to enter into or perform its obligations under this Agreement.

“Non-Assignable Assets” is defined in Section 12.9(a) of this Agreement.

"Non-Return Taxes" is defined in Section 11.1 of this Agreement.

"Order" means any award, writ, stipulation, injunction, judgment, order, decree, ruling, subpoena or verdict entered, issued, made or rendered by, or any contract with, any Governmental Authority.

"Permitted Liens" means (i) Liens for Taxes not yet due and payable, (ii) easements, covenants, conditions and restrictions of record, (iii) easements, covenants, conditions and restrictions not of record as to which no material violation or encroachment exists or, if such violation or encroachment exists, as to which the cure of such violation or encroachment would not materially interfere with the conduct of the Business, (iv) any zoning or other governmentally established restrictions or encumbrances, (v) workers or unemployment compensation Liens arising in the ordinary course of business securing amounts which are not delinquent, (vi) mechanic's, materialman's, supplier's, vendor's or similar Liens arising in the ordinary course of business securing amounts which are not delinquent, and (vii) other immaterial imperfections of title, easements, covenants, conditions, restrictions or encumbrances.

"Person" means any natural person, corporation, limited liability company, unincorporated organization, partnership, association, joint-stock company, joint venture, trust or Governmental Authority or other entity.

"Purchased Personal Property" is defined in Section 2.1(i) of this Agreement.

"Purchaser" is defined in the preamble of this Agreement.

"Purchaser's Knowledge" means the actual knowledge, after reasonable inquiry, of any officer of Purchaser having authority over the subject matter in question.

"Purchaser's Required Consents" is defined in Section 7.3 of this Agreement.

"Required Consents" is defined in Section 6.3 of this Agreement.

"Required Employees" is defined in Section 12.4(d) of this Agreement.

"Seller" is defined in the preamble of this Agreement.

"Seller's Knowledge" means the actual knowledge of Harold Dodd or Rob Molenaar or Robin Randall.

"Statement of Inventory Value" is defined in Section 3.1(b)(i) of this Agreement.

"Tax" means any federal, state, county, local, municipal or foreign taxes, charges, fees, levies or other assessments, including all net income, net worth, estimated, gross income, sales and use, ad valorem, value added, goods and services, transfer, gains, profits, excise, franchise, real and personal property, gross receipt, capital, capital stock, production, business and occupation, disability, employment, payroll, social security (or similar), employment and worker's compensation insurance, license, stamp, custom duties, severance or withholding taxes or charges imposed by any Governmental Authority and any charges, interest and penalties (civil or criminal) on, in lieu of or for noncollection of or additions to any such taxes, whether disputed or not.

"Tax Returns" means any report, return or other information required to be supplied to a Governmental Authority with respect to Taxes.

"Terminating Employees" is defined in Section 12.4(d) of this Agreement.

"Third Party Claim" is defined in Section 13.4 of this Agreement.

"Transaction" means the transactions contemplated under this Agreement.

"United States" means the United States of America.

1.2 Other Definitional and Interpretive Provisions.

(a) Unless otherwise defined therein, all terms defined in this Agreement shall have such meanings when used in any certificate, report or other document made or delivered pursuant hereto.

(b) Certain information contained on certain schedules to this Agreement may not have been required pursuant to the terms of this Agreement to be listed on such schedules. Any disclosure made in any schedule to this Agreement which should, based on the substance of such disclosure, be applicable to another schedule to this Agreement shall be deemed to be made with respect to such other schedule regardless of whether or not a specific reference is made thereto.

SECTION 2

SALE OF ASSETS

2.1 Purchase and Sale of Assets. Effective as of the close of business on the Closing Date, Seller shall, or shall cause each of its foreign subsidiaries to, convey, transfer and assign to Purchaser all of Seller's right, title and interest in and to the

following properties, interests and assets which are used exclusively in the Business (individually an "Acquired Asset" and collectively, the "Acquired Assets"), free and clear of all Liens, except as specifically assumed by Purchaser pursuant to the terms of this Agreement and except for Permitted Liens:

- (a) all of the outstanding shares of capital stock of Akzo Nobel Non-Stick Coatings Limited, a corporation organized under the laws of India ("AN India") including, with the purchase of AN India, the assets of AN India which are covered by Section 2.1(b) through (i) below and, if applicable, specifically set forth on the applicable Schedule;
- (b) customer and client lists, including prospective customer and client lists, customer and client accounts and information, vendor lists and information, services, techniques, methods of operation, prices, costs, sales, sales strategies and methods, products, product development, policies, business strategies and plans pertaining exclusively to the Business;
- (c) all Intellectual Property owned by Seller and used by Seller exclusively in the conduct of the Business, including without limitation, all patents, patent applications and trademarks identified on Schedule 2.1(c) attached hereto;
- (d) all Inventory;
- (e) all contracts, leases, commitments, obligations and liabilities relating exclusively to the Business listed on Schedule 2.1(e) (excluding this Agreement and the agreements, instruments and documents executed and delivered by Purchaser pursuant to this Agreement) (collectively, the "Assumed Contracts");
- (f) the books and records of Seller relating exclusively to the Acquired Assets;
- (g) subject to applicable laws and regulations and to the extent transferable, all licenses and other regulatory approvals for or incident to the operation of the Business identified on Schedule 2.1(g) attached hereto;
- (h) all Leased Real Property set forth on Schedule 2.1(h) attached hereto; and
- (i) all personal property identified on Schedule 2.1(i) attached hereto (the "Purchased Personal Property").

2.2 Excluded Assets. The parties understand and agree that Seller is not transferring to Purchaser any assets or properties not specifically referred to in Section

2.1, including, without limitation, those assets of Seller set forth below (the "Excluded Assets"):

- (a) cash and cash equivalents held by Seller or AN India, including without limitation, bank accounts, certificates of deposit, treasury bills, securities, money market accounts, mutual funds and repurchase agreements, prepaid expenses and security deposits;
- (b) Intellectual Property of Seller or AN India with respect to waterborne soft touch coatings;
- (c) Intellectual Property used in the Business and also utilized in other lines of business of Seller; provided, however, at Closing, Seller shall grant to Purchaser a license to use certain trademarks which are jointly used, mutually agreed to by the parties, pursuant to a license agreement in the form substantially attached hereto as Exhibit "B" (the "License Agreement");
- (d) all assets, properties and other rights owned by Seller or AN India which are not exclusively related or used in the Business;
- (e) all furniture, fixtures, equipment and other personal property owned by Seller or AN India (excluding any Acquired Asset) which are used in or related to the Business; and
- (f) all accounts receivable and related records of Seller or AN India pertaining to the operation of the Business prior to and as of the Closing Date.
