ASSIGNMENT OF
UNITED STATES TRADEMARK REGISTRATION

The trademark *Francis Ford Coppola Presents* registered with the United States Patent and Trademark Office under registration no. 1,934,649 on November 14, 1995 (the "Mark") was inadvertently transferred to Assignor on January 10, 2006 as one of several *Francis Coppola* trademarks acquired from Francis Coppola, as Trustee of The Coppola Family Trust (the "Trust"). It was the Trust's intention to transfer the Mark to Assignee in connection with the sale of Assignee. As an accommodation to the Trust, Assignor now desires to transfer the Mark to Assignee, effective as of the date that the Mark was transferred to Assignor.


