### RECITALS:

WHEREAS, Assignor appears as owner or record and/or may otherwise be the owner of certain trademark rights identified below (the "H.R. Trademarks"), without verifying the validity of the H.R. Trademarks, and the goodwill, if any, symbolized thereby and the common law rights, if any, therein:

Trademarks, if any, together with the goodwill, if any, of the business associated therewith and which is symbolized thereby, and any and all renewals and extensions thereof that may hereafter be secured under the laws now or hereafter in effect in the United States and in any other jurisdiction, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment and sale had not been made, together with all income, royalties or payments due or payable as of the Effective Date or thereafter, including, without limitation, any such payments resulting from past, present or future infringement or other unauthorized use of the H.R. Trademarks, together with the right to sue for and collect the same.

Assignor requests that the appropriate governmental Trademark Office record Assignee as the acquirer and owner of the H.R. Trademarks.

Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Assignment shall be governed by and construed in accordance with the laws of the State of New Jersey without giving effect to the principles of conflicts of laws thereof.

This Assignment may be executed in any number of counterparts, each of which shall be deemed to be an original, and all of which together shall constitute one and the same instrument.

The parties agree (a) to furnish upon request to each other such further information, (b) to execute and deliver to each other such other documents, and (c) to do such other acts and things, all as the other party may reasonably request from time to time for the purpose of carrying out the intent of this Assignment.

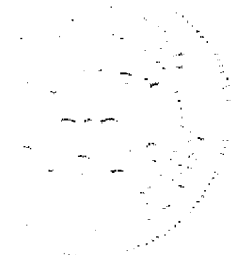
