As per my voicemail, we received your name and contact information from email exchanges with Blake Ilstrup and Alan Hambelton at Cooley in Washington. I am representing Antenna Software, Inc. in connection with the recent acquisition of Dexterra, Inc and the post-closing clean-up of its intellectual property. Below are 2 marks that currently have a security interest in favor of SVB filed against them with the USPTO. The pay-off letter that we received from SVB does not authorize us to file the necessary terminations to the security interest notifications, so we're reaching out to you in the hopes that you can help facilitate the necessary filings. Note that Antenna's current lender is requiring these filings and the company is up against a short post-closing timetable to satisfy the lender's requirements.
