
TRADEMARK ASSIGNMENT

Pursuant to the Asset Sale and Purchase Agreement by and among The Procter & Gamble Company, an Ohio corporation ("P&G"), and Noxell Corporation, a Maryland corporation (collectively, "Sellers") and Alberto-Culver USA, Inc., a Delaware corporation ("Buyer"), relating to Sellers' Noxzema business and dated September 5, 2008 ("Agreement"), for good and valuable consideration to them paid by Buyer, receipt of which is hereby acknowledged and agreed, P&G and Noxell hereby each sell, convey, assign and transfer to Buyer (i) all of its right, title and interest in and to the trademarks, trademark registrations and trademark applications and trade dress (Trademarks") set forth or described on Attachment A hereto along with the associated goodwill, and (ii) all of its rights to all causes of action and other claims for past infringements or other violations of rights in the Trademarks including the right to recover for damages and profits and all other remedies for such past infringements or other violations thereof. All capitalized terms used, but not defined herein, have the meanings set forth in the Agreement.
