## ARTICLES OF AMENDMENT

Pursuant to §55-10-06 of the General Statutes of North Carolina, the undersigned corporation hereby submits the following Articles of Amendment for the purposes of amending its Articles of Incorporation:

1. The name of the corporation is SVE Sales, Inc.
2. The text of the amendment adopted is as follows:

RESOLVED, that Paragraph 1 of the Articles of Incorporation be deleted in its entirety and the following language be substituted in lieu thereof:

“1. The name of the corporation is SVE Portable Roadway Systems, Inc.”

3. This amendment does not provide for any exchange, reclassification, or cancellation of issued shares insomuch as it merely provides for a corporate name change.
4. The amendment was approved by shareholder action on April 3, 2007, and such shareholder approval was obtained as required by Chapter 55 of the North Carolina General Statutes.
5. This Articles will be effective upon filing.
