RELEASE OF SECURITY INTEREST

WHEREAS, pursuant to that certain Patent and Trademark Security Agreement ("Security Agreement") entered into on May 8, 2008 between Country Creek Farms, L.L.C., a Tennessee limited liability company ("CCF"), and Wells Fargo Bank, National Association ("Wells Fargo"), CCF granted a security interest to Wells Fargo in certain Patents and Trademarks (as defined in the Security Agreement) described therein (the "Secured Property").

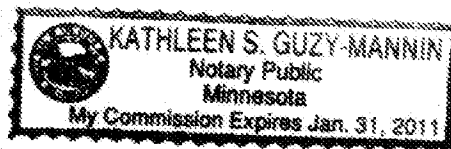
