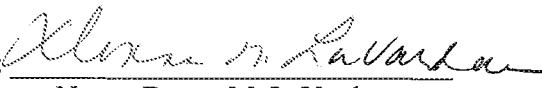
THIS AGREEMENT, is effective as of November 8, 2004.
