TRADEMARK ASSIGNMENT

WHEREAS, Western Plant Breeders, Inc. (hereinafter, "Assignor") has adopted and used the mark WESTBRED (U.S. Reg. No. 1,079,036) since at least as early as 1977 in connection with Grain seed in International Class 001 and has common law rights in the tradename WESTBRED (collectively, the common law rights and federal registration, hereinafter, "Marks");

WHEREAS, WestBred, LLC (hereinafter, "Assignee") previously acquired all rights, title and interests of Assignor in the Marks, including the goodwill associated therewith, by way of that certain assignment executed on August 4, 2003 between Assignor and Assignee, and is desirous of memorializing that prior assignment for recordation in the United States Patent and Trademark Office;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor assigns, sells, and transfers to Assignee, its successors and assigns, all right, title, and interest in and to the Marks, together with the goodwill and all common law rights associated therewith, *nunc pro tunc* with respect to the August 4, 2003 assignment between Assignor and Assignee. Assignor further authorizes the Director – United States Patent and Trademark Office to record this Trademark Assignment for the sole benefit of Assignee, its successors, assigns, and legal representatives in connection with any Federal registrations or applications for the Mark.

IN TESTIMONY WHEREOF, the parties have executed this Trademark Assignment by their duly authorized officers.


