## TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT ("Assignment") is made as of 28 August, 2008, from Smethport Specialty Company, a Pennsylvania corporation ("Assignor") to Patch Products, Inc., a Wisconsin corporation ("Assignee").

## RECITALS

A. Pursuant to an Asset Purchase Agreement dated August 13, 2008, between Assignor and Assignee (the "Asset Purchase Agreement"), Assignee has agreed to purchase substantially all of the assets of the Assignor. The execution and delivery of this Assignment is a condition to the obligation of Assignee to consummate the transactions contemplated by the Asset Purchase Agreement.

B. Assignor is the owner of the Assigned Trademarks (as defined below).

C. Assignor desires to grant an assignment of all of its right, title, and interest in and to the Assigned Trademarks to Assignee.

## AGREEMENT

For valuable consideration (including that recited in the Asset Purchase Agreement), the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee mutually agree as follows:

1. Definition of Assigned Trademarks. The term "Assigned Trademarks" shall mean the trademark registrations listed in Appendix A, as well as: (a) all common law rights therein; (b) all goodwill associated therewith; (c) all renewals thereof; and (d) all rights of action, powers and benefits accrued thereto, including the right to sue for and collect damages and payments for past or future infringements thereof.

2. Assignment of the Assigned Trademarks. Assignor hereby sells, assigns, and transfers to Assignee, its successors and assigns all of Assignor's right and title to and interest in the Assigned Trademarks.




