**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY ("Release") is made effective as of July 10, 2009, by JPMorgan Chase Bank, N.A., as Collateral Agent (the "Lender") to Investools Inc., Prophet Financial Systems, Inc., and Thinkorswim Group, Inc. (the "Grantors"), as follows:

WHEREAS, on February 13, 2007, the Grantors and the Lender entered into a Security Agreement ("1<sup>st</sup> Security Agreement");

WHEREAS, on August 21, 2008, Thinkorswim Group, Inc. and the Lender entered into a Security Agreement ("2nd Security Agreement");

WHEREAS, pursuant to said 1<sup>st</sup> Security Agreement, the Grantors granted to the Lender, among other collateral, a continuing security interest in all of the Grantors' right, title and interest, including goodwill in trademarks, in, to and under the United States Trademarks listed on the attached Schedule A (the "Marks") and the United States Patents listed on the attached Schedule B (the "Patents");

WHEREAS, pursuant to said 2nd Security Agreement, Thinkorswim Group, Inc. granted to the Lender, among other collateral, a continuing security interest in all of Thinkorswim Group, Inc.'s right, title and interest, including goodwill in trademarks, in, to and under the United States Trademarks listed on the attached Schedule C (the "Marks");

WHEREAS, said 1<sup>st</sup> Security Agreement was recorded with the United States Patent & Trademark Office with respect to Trademarks on March 9, 2007, at reel/frame 3496/963, as well as a Corrective Assignment on May 8, 2007, at reel/frame 3539/347 to correct the name of the conveying party from Thinkorswim Technologies to Thinkorswim Group and to correct the address of the receiving party previously recorded at Reel/Frame 3496/963;

WHEREAS, said 1<sup>st</sup> Security Agreement was recorded with the United States Patent & Trademark Office with respect to Patents on March 9, 2007, at reel/frame 18989/167, as well as a Corrective Assignment on May 8, 2007, at reel/frame 19287/030 to correct receiving party's street address previously recorded at Reel/Frame 18989/167; and

WHEREAS, said 2nd Security Agreement was recorded with the United States Patent & Trademark Office on August 22, 2008, at reel/frame 3839/772.

NOW THEREFORE, as the Grantors have satisfied the obligations under said security agreements, the Lender hereby releases its security interest in and lien upon the Marks and Patents, and reassigns any and all interest it may have in the Marks and Patents to the Grantors.
