## RELEASE OF SECURITY INTEREST

WHEREAS, John A. Williams, Turner Foundation, Inc., Arthur M. Blank, Ronald de Waal and Interhim, N.V. WHEREAS, the Investor Notes were secured by certain assets of the Company.

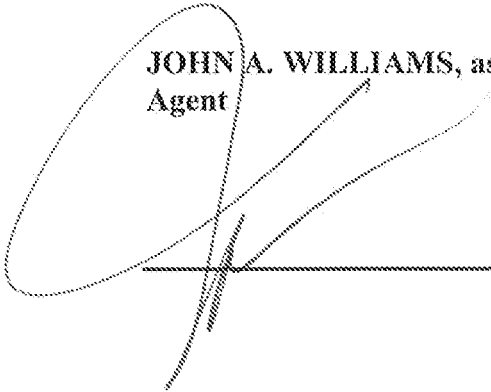
