PATENT SECURITY AGREEMENT

This PATENT SECURITY AGREEMENT ("Agreement") is made as of the 26<sup>th</sup> day of June, 2009, by and between 38 Studios, LLC, a Delaware limited liability company, having its principal office at 5 Clock Tower Place, 1<sup>st</sup> Floor, Maynard, Massachusetts 01754 and 38 Studios Baltimore, LLC, a Delaware limited liability company, having a principal office at 1954 Greenspring Drive, Timonium, Maryland 21093 (collectively the "Grantors"), and Haymarket Capital, LLC, a Massachusetts limited liability company, having its principal office at 2 Clock Tower Place, Maynard, Massachusetts 01754 ("Grantee").

WHEREAS, Grantors are the owners of the U.S. trademark applications listed on the attached Schedule A, the U.S. registered trademarks listed on the attached Schedule B, the U.S. patent application listed on the attached Schedule C, and the U.S. copyright listed on the attached Schedule D (collectively the "Intellectual Property");


WHEREAS, Grantee has extended a loan to Grantors pursuant to the terms and conditions of that certain Promissory Note dated as of June 26, 2009 ("Note") made by Grantors in favor of Grantee;

WHEREAS, under a Security Agreement dated as of June 26, 2009 ("Security Agreement") between Grantors and Grantee, Grantors have granted to Grantee a security interest in certain of its assets (including the Intellectual Property) to secure the performance of the obligations of Grantors under the Note; and


WHEREAS, Grantors and Grantee by this instrument seek to confirm and make a record of the grant of a security interest in the Intellectual Property.

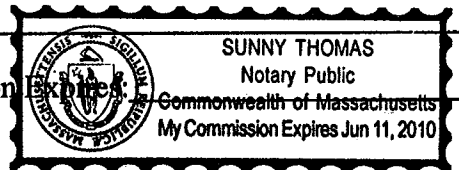

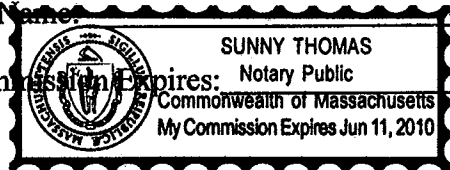
