CONFIRMATORY ASSIGNMENT

THIS CONFIRMATORY ASSIGNMENT is made the 11 day of July 2009 in respect to assignment effective as of March 21, 2001.

BETWEEN:

- I. ROBERT LATCHMAN ("ASSIGNOR"), a Canadian and USA citizen, whose address is 1092 St. George Avenue, Unit 166, Rahway, New Jersey USA 07065; and
- II. WORLDWIDE MANAGEMENT LLC ("ASSIGNEE"), a Limited Liability Company organized in the USA State of New Jersey, whose address was 1162 St. George Avenue, Unit 264, Rahway, New Jersey, USA 07065.

INTRODUCTION:

- A. ASSIGNOR was the owner of the mark CHAMPION and all right, title and interest to the mark CHAMPION, including any and all government filings related to the mark CHAMPION (such rights at the time of the assignment included but were not limited to the applications for (1) the United States Trademark Registration No. 3,051,908 ("3051908 REGISTRATION") for the mark CHAMPION for the goods: "butter, edible oils, meat in cans, butter oil," in International Class 29 and "processed cereals for infants, rice, sugar, starch for foods, powder for making custard, curry powder, flavouring extracts (non-essential oils) spices and spice blends," in International Class 30 and (2) the United States Trademark Registration No. 2,212,358 ("2212358 Registration") for the mark CHAMPION for the goods "butter, edible oils, meat in cans, butter oil, mashed potatoes and unsweetened and unflavoured gelatin," in International Class 29 and "processed cereals for infants, flour, rice, sugar, starch for foods, powder for making custard, curry powder, flavouring extracts made of non-essential oils, spices, spice blends, coffee, yeast, meat tenderizer, baking powder," in International Class 30;
- B. ASSIGNEE was desirous of acquiring and did so acquire all right, title and interest in and to the CHAMPION trademark, together with the goodwill of the business with which the mark was used and which was symbolized by the mark, and the right of recovery in all legal actions based on such mark;
- C. ASSIGNOR and ASSIGNEE entered into an Agreement dated March 21, 2001 (the "2001 Agreement") (attached at Schedule 1) whereby ASSIGNOR agreed to assign to ASSIGNEE all right, title and interest in and to the mark CHAMPION, together with the goodwill of the business with which the mark was used and which was symbolized by the mark, and the right of recovery in all legal actions based on such mark;
- D. ASSIGNOR assigned the CHAMPION mark, identifying it as the 2212358 Registration, to ASSIGNEE on March 21, 2001;

- E. ASSIGNOR intended to and did assign any and all of its interests in the mark CHAMPION from ASSIGNOR to ASSIGNEE as of March 21, 2001; and
- F. Now the parties wish to record the 2001 Agreement as it relates to the 3051908 REGISTRATION.

NOW THIS CONFIRMATORY ASSIGNMENT WITNESSETH AS FOLLOWS:

1. ASSIGNMENT

Pursuant to the 2001 Agreement, ASSIGNOR hereby confirms that on March 21, 2001, it irrevocably and absolutely assigned to ASSIGNEE its entire right, title and interest in and to the mark CHAMPION, together with the goodwill of the business in connection with which the mark was used and which was symbolized by the mark, as fully and entirely as the same would have been held and enjoyed by it if an assignment had not been made, including the right to pursue all actions based on such mark and to recover for past infringement or violations of law relating to said mark, the same to be held and enjoyed by the ASSIGNEE and its legal representatives, successors and assigns, for its own use and enjoyment, and for the use and enjoyment of its assigns, successors, or other legal representatives, as fully and entirely as if the same would have been held and enjoyed by the ASSIGNOR had this Assignment not been made, including the 3051908 REGISTRATION. Therefore, this Confirmatory Assignment confirms the assignment of said CHAMPION mark, 3051908 REGISTRATION, as of March 21, 2001.

2. FURTHER ASSURANCE

Assignor shall, as and when requested by Assignee, and at the expense of Assignor, do all acts and execute all documents as may reasonably be necessary or desirable to give full effect to this Confirmatory Assignment and the Assignment of the CHAMPION mark.

3. LAW AND JURISDICTION

This Confirmatory Assignment and the 2001 Agreement shall be governed by U.S. and Canadian Law. Where there is a conflict of law, Canadian law shall govern.
