RELEASE OF SECURITY INTEREST

This RELEASE OF SECURITY INTEREST dated as of July 15, 2009 (this "**Release Agreement**") is made by Wilmington Trust FSB ("**Wilmington Trust**"), in favor of the Persons listed on the signature pages hereof (each a "**Grantor**" and collectively, the "**Grantors**").

WHEREAS, the Grantors have entered into the Second Lien Senior Secured Credit Agreement, dated as of August 14, 2007 (as amended, supplemented or otherwise modified to date, the "**Second Lien Credit Agreement**"), with the lenders from time to time party thereto (each a "**Lender**" and collectively, the "**Lenders**"), and Wilmington Trust (as successor to Credit Suisse, Cayman Islands Branch), as administrative agent and collateral agent for the Lenders (in such capacities, the "**Agent**"). Terms defined in the Second Lien Credit Agreement and not otherwise defined herein are used herein as defined in the Second Lien Credit Agreement.

WHEREAS, as a condition precedent to the making of loans by the Lenders under the Second Lien Credit Agreement, each Grantor has executed and delivered to the Agent that certain Second Lien Guarantee and Collateral Agreement, dated as of August 14, 2007 (as amended, supplemented or otherwise modified to date, the "**Second Lien Guarantee and Collateral Agreement**").

WHEREAS, under the terms of the Second Lien Guarantee and Collateral Agreement and the related short-form Second Lien Intellectual Property Security Agreement, dated as of August 14, 2007 (as amended, supplemented or otherwise modified to date, the "**Short-Form Agreement**"), the Grantors have granted to the Agent, for the ratable benefit of the Secured Parties, a security interest in the Collateral (as defined in the Short-Form Security Agreement) (the "**Security Interest**").

WHEREAS, the Security Interest was recorded in the Trademark Division of the United States Patent and Trademark Office as of September 5, 2007 at Reel 3615, Frame 0581, and at the United States Copyright Office as of September 5, 2007 at Volume 3566, Document No. 500.

WHEREAS, Wilmington Trust succeeded to Credit Suisse, Cayman Islands Branch, as Administrative Agent and Collateral Agent pursuant to the Successor Agent and Amendment Agreement, dated as of January 27, 2009, by and among Credit Suisse, Wilmington Trust, the Required Lenders party thereto and the Borrower (the "**Successor Agent Agreement**").

WHEREAS, the Successor Agent Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office as of May 5, 2009 at Reel 3982, Frame 0389.

WHEREAS, Grantors have requested that the Agent terminate and release the entirety of its Security Interest in the Collateral and the Agent is willing to do so.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent agrees as follows:

Section 1. Termination and Release. The Agent hereby releases, terminates and discharges fully its Security Interest and releases its entire right, title and interest in the Collateral (if any), including, but not limited to, the following:

- (a) the patents and patent applications set forth in Schedule A hereto (the "**Patents**");
- (b) the trademark and service mark registrations and applications set forth in Schedule B hereto, together with the goodwill symbolized thereby (the "**Trademarks**");
- (c) the copyright registrations and applications and exclusive copyright licenses set forth in Schedule C hereto (the "**Copyrights**");
- (d) all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing, all rights in the foregoing provided by international treaties or conventions, all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of such Grantor accruing thereunder or pertaining thereto;
- (e) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages; and
- (f) any and all proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, and supporting obligations relating to, any and all of the Collateral of or arising from any of the foregoing.


Section 2. Further Assurances. The Agent hereby agrees to execute such instruments and to take such other actions as any of the Grantors may reasonably request to terminate the Agent's Security Interest in the Collateral, and otherwise to effectuate the release of the Collateral from the Agent's Security Interest.

Section 3. Governing Law. This Release Agreement shall be governed by and construed and interpreted in accordance with the laws of the State of New York, applicable to agreements made and wholly performed therein.


