## ASSIGNMENT OF TRADEMARK

THIS ASSIGNMENT OF TRADEMARK, (the“Assignment”) is entered into as of this 8th day of July, 2009, by and between ProMark Brands Inc., including its parent, subsidiaries, direct and indirect affiliates and related companies (collectively,“ProMark”) and Market Connections, LLC (“Market Connections”). ProMark and Market Connections are sometimes hereinafter individually referred to as a“Party”and collectively as the“Parties.”

WHEREAS, ProMark and Market Connections are parties to that certain Settlement Agreement, dated as of June 30, 2009 (as amended, modified, restated or supplemented, the “Agreement”), pursuant to which ProMark has agreed to convey, transfer, assign and deliver to Assignee, all of the right, title and interest of ProMark in and to the trademark application listed on Schedule A hereto, and all common law rights associated therewith, together with all goodwill arising from the use of and symbolized by said trademark (the“Trademark”); and

WHEREAS, ProMark desires to convey, transfer, assign, and deliver to Market Connections, and Market Connections desires to acquire, all of ProMark’s right, title and interest in and to the Trademark.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ProMark does hereby assign, transfer, convey and deliver to Market Connections, and Market Connections acquires from ProMark, all of ProMark’s right, title and interest in and to the Trademark, the goodwill of the business symbolized by the Trademark, all rights to sue, counterclaim, and to collect damages and payments for claims of past, present, and future infringements, unfair competition or misappropriations thereof, and all income, royalties, damages and payments now or hereafter due or payable with respect thereto, for Market Connections’ own use and enjoyment, and for the use and enjoyment of Market Connections’ successors, assigns or other legal representatives.
