TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT is made this 9th day of June, 2009 by Precision Valve Corporation, a New York corporation (“**Assignor**”), to CA Acquisition, LLC, an Illinois limited liability company, d/b/a Chicago Aerosol (“**Assignee**”).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor has sold, transferred, conveyed, assigned and set over, and does hereby sell, transfer, convey, assign and set over to Assignee, its successors, legal representatives and assigns, all of Assignor’s right, title and interest in, to and under the Trademarks, together with the goodwill associated with the Trademarks (including, without limitation, all proceeds thereof and the rights to sue for past, present and future damages), the same to be held and enjoyed by Assignee, for its own use and on behalf of its successors, legal representatives and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor, had this sale and assignment not been made.

Assignor hereby authorizes and requests the Commissioner of Trademarks to record Assignee as the owner of the Trademarks and to issue all registrations for said Trademarks to Assignee, as assignee of the applicable trademark registrations listed on Schedule A, for the sole use and enjoyment of the Assignee, its successors, legal representatives and assigns.


